



#### PACKAGE DIMENSIONS W/PCB MOUNTING BRACKET





#### ANTI-ROTATION LUG (Style "A", 90 ° CW Shown)





#### Recommended PCB Layout








#### **Electrical Schematic**

#### **Terminal Layout**








