


# Package Outline Dimensions: (mm) DO-214AB (SMC)






### FORWARD CURRENT DERATING CURVE




# MAXIMUM NON REPETITIVE PEAK FORWARD SURGE CURRENT




### TYPICAL FORWARD CHARACTERISTIC
