1. General description

The 74LVT244A; 74LVTH244A is a high-performance BiCMOS product designed for V_{CC} operation at 3.3 V.

This device is an octal buffer that is ideal for driving bus lines. The device features two output enables ($\overline{1OE}$, $2OE$), each controlling four of the 3-state outputs.

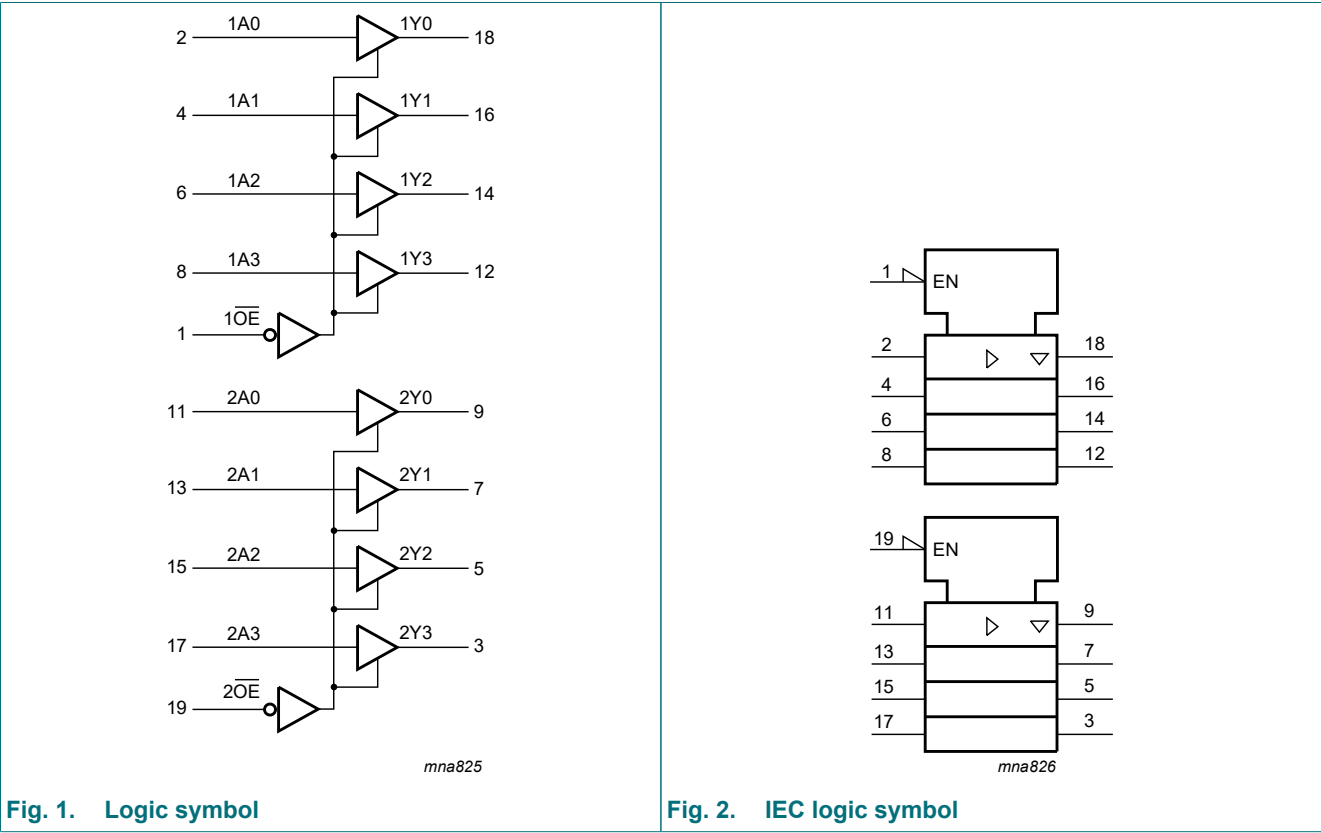

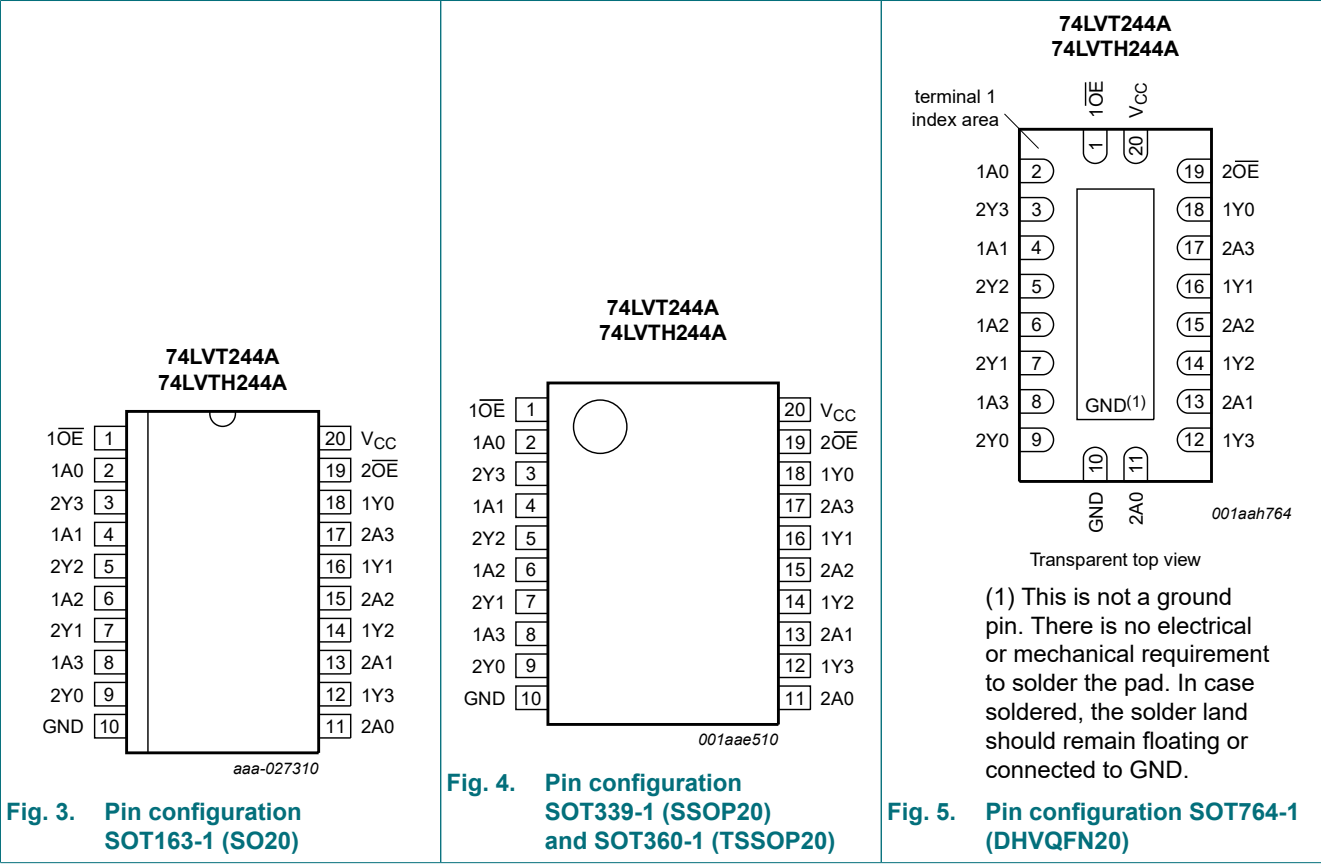


Fig. 4. Pin configuration SOT339-1 (SSOP20) and SOT360-1 (TSSOP20)

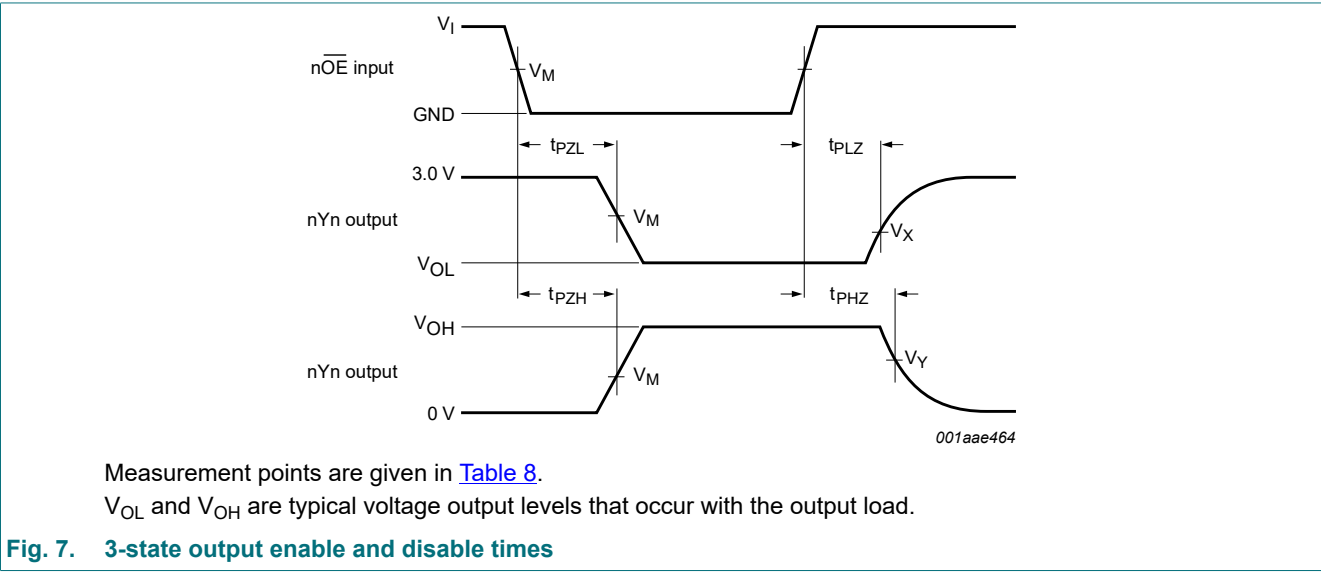
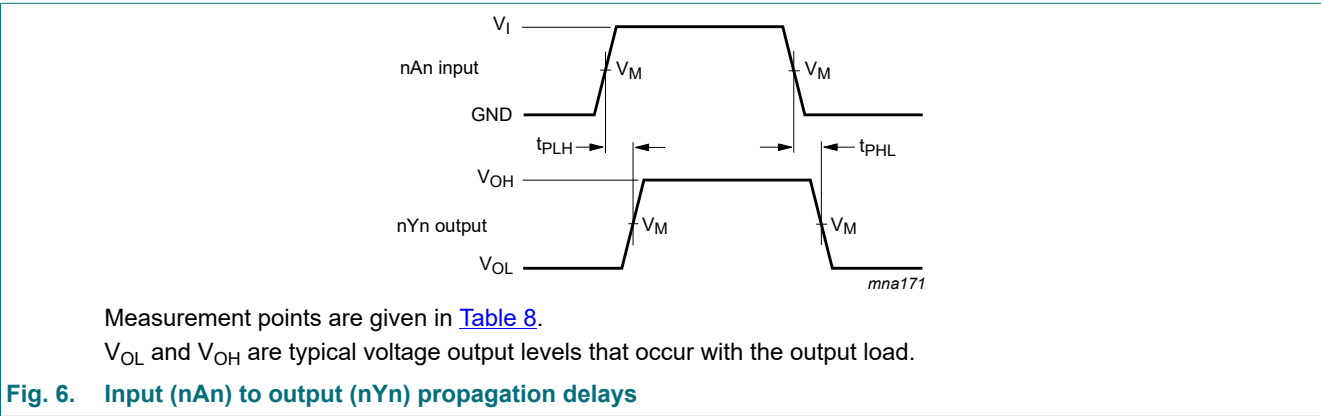
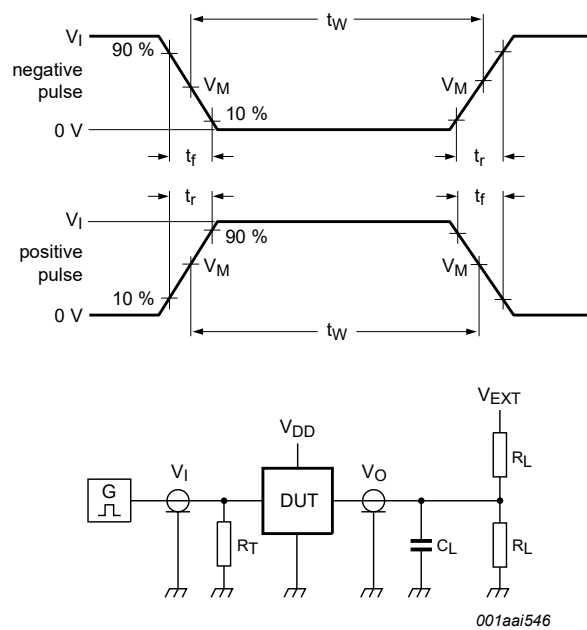

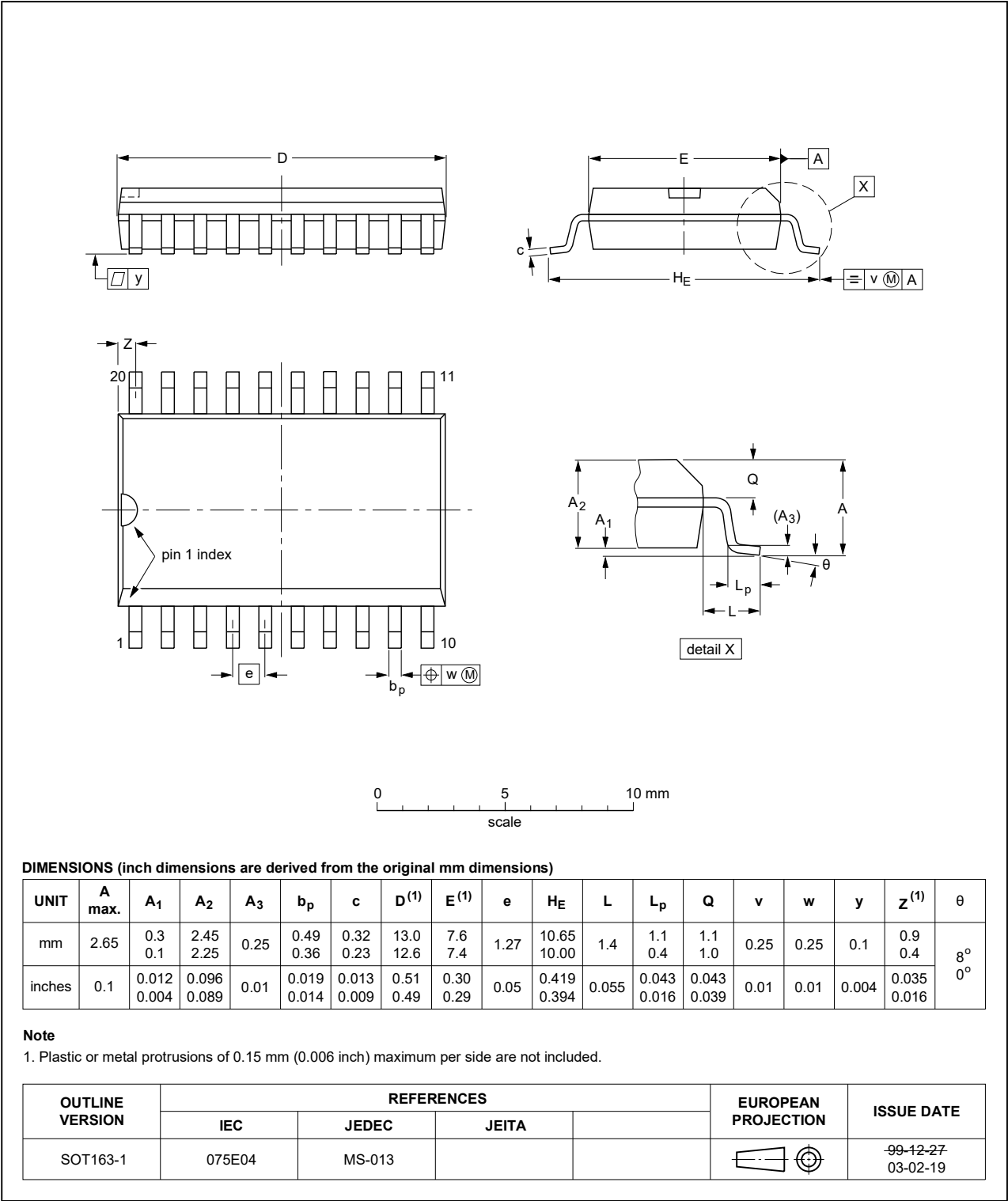


Fig. 9. Package outline SOT163-1 (SO20)

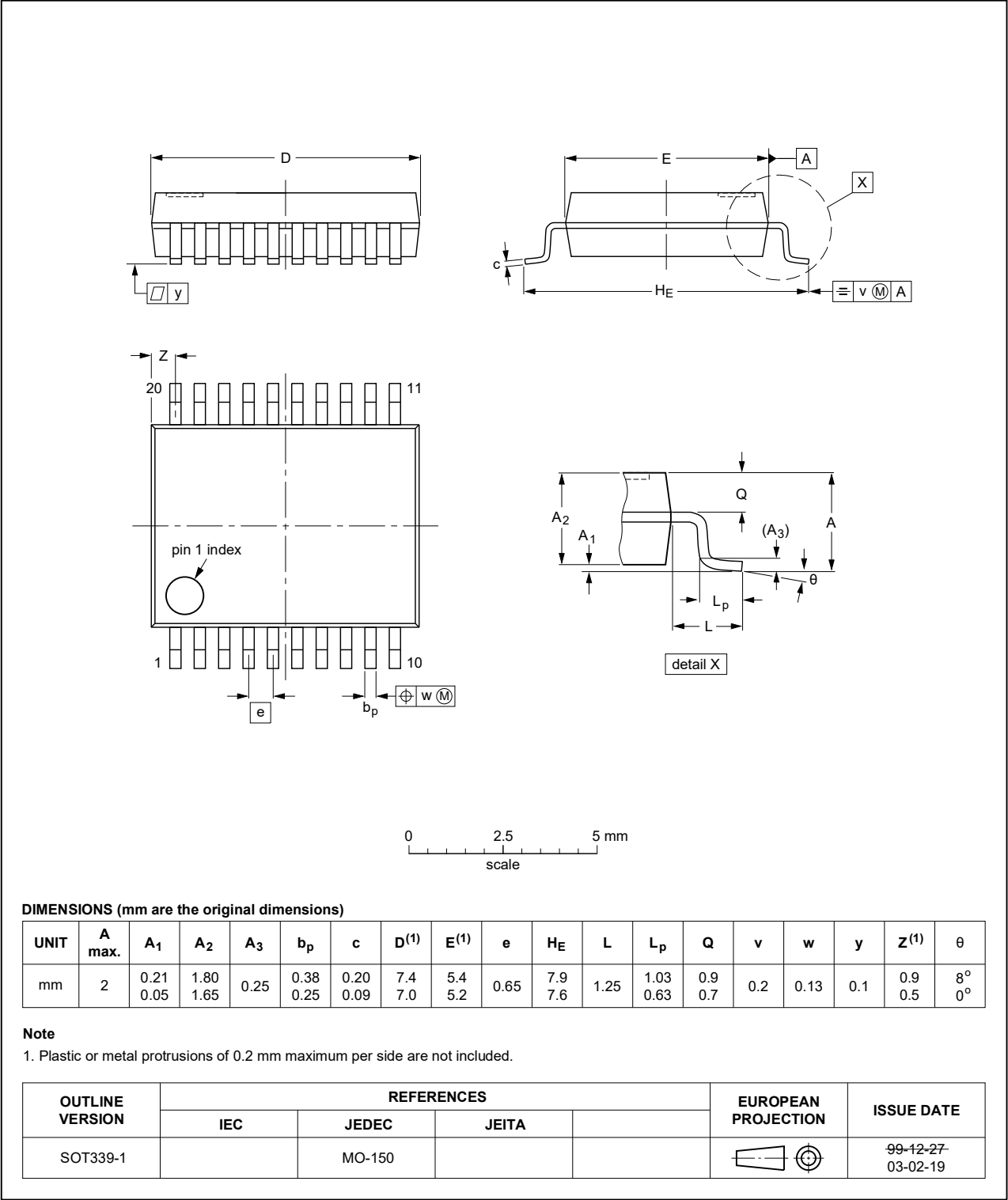


Fig. 10. Package outline SOT339-1 (SSOP20)

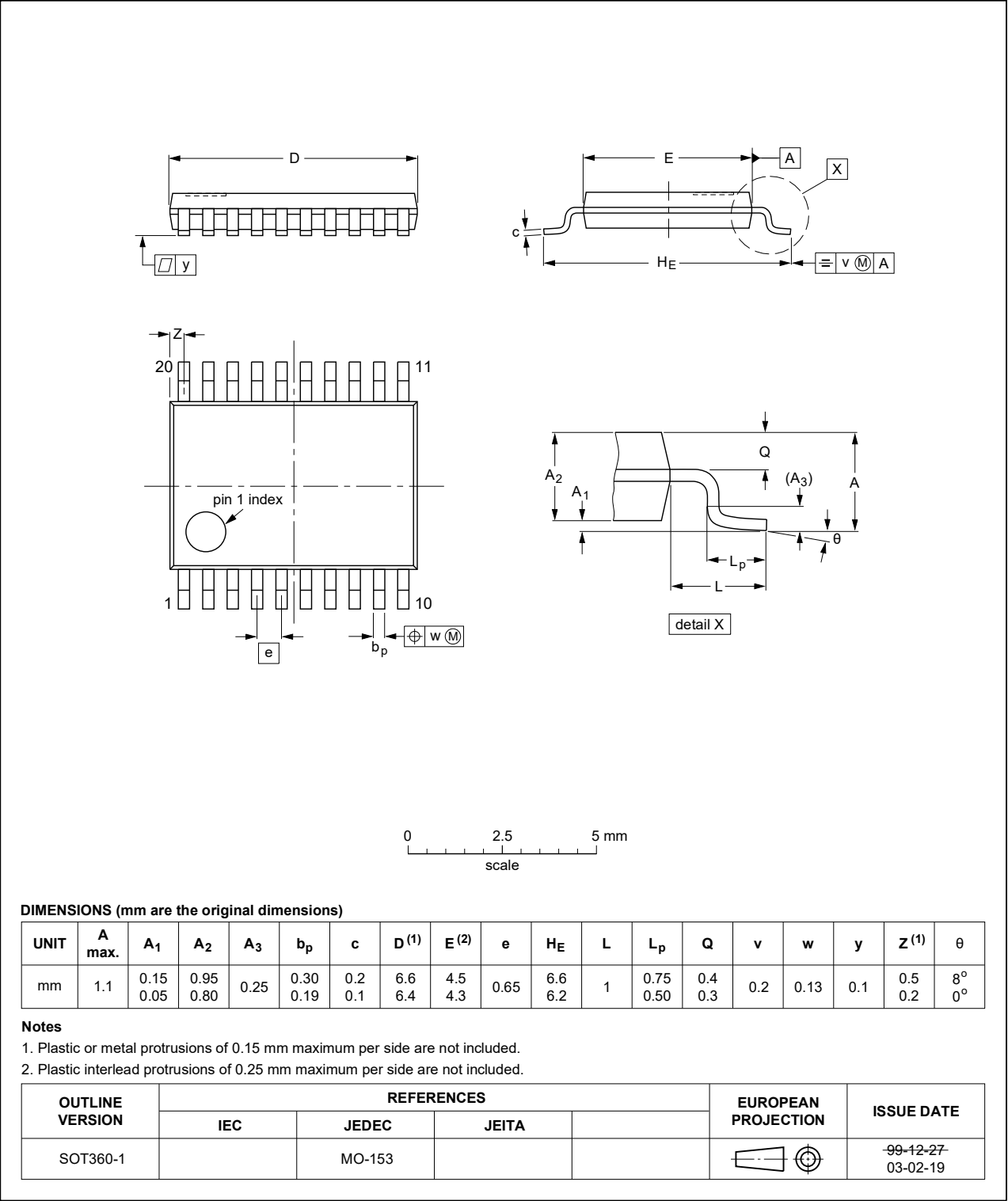


Fig. 11. Package outline SOT360-1 (TSSOP20)

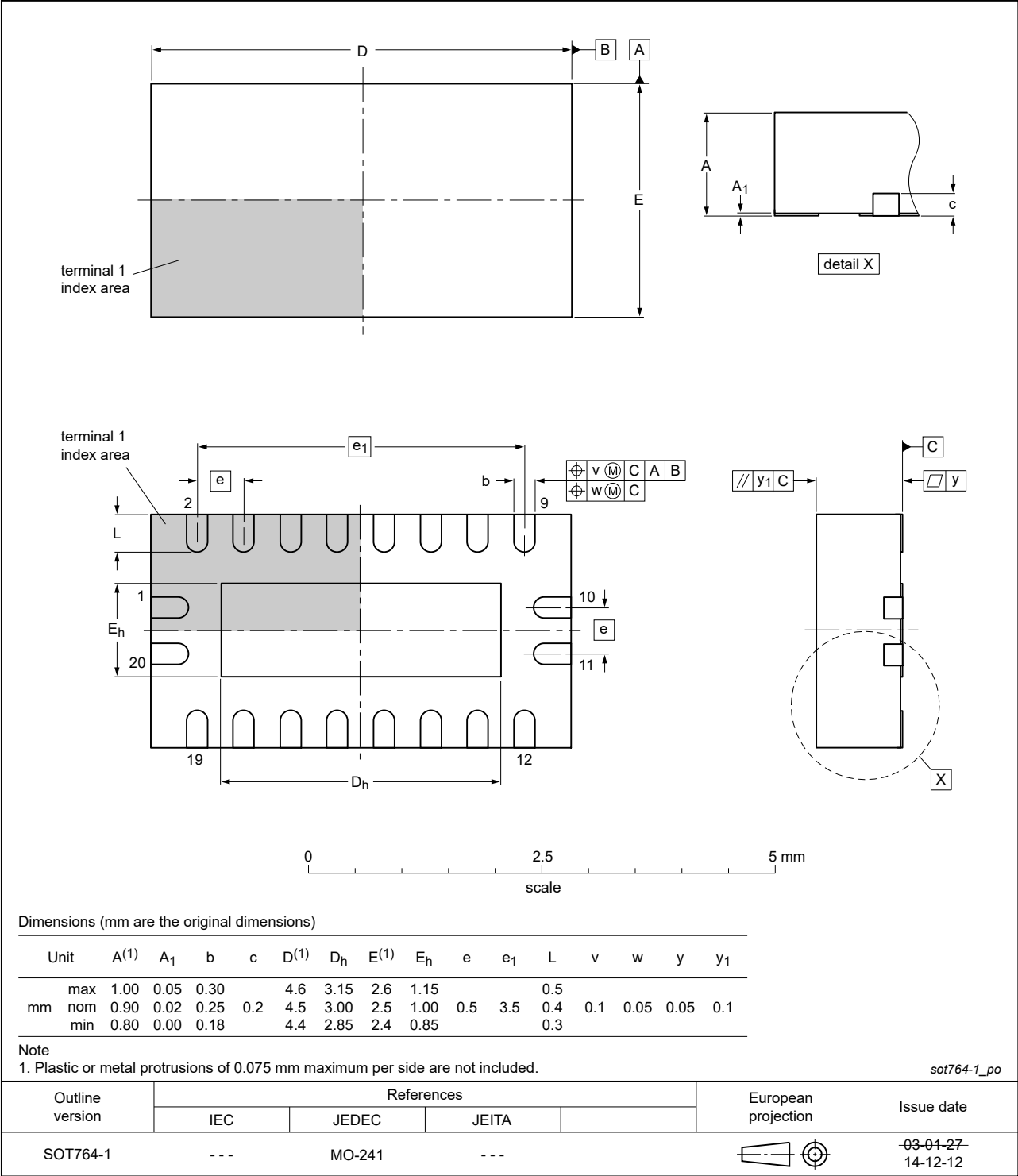


Fig. 12. Package outline SOT764-1 (DHVQFN20)
