Product data sheet

1. General description

The CBT3253 is a dual 1-of-4 high-speed TTL-compatible FET multiplexer/demultiplexer. The low ON-resistance of the switch allows inputs to be connected to outputs without adding propagation delay or generating additional ground bounce noise.

The select control inputs (S0, S1) can select the data path, when both output enable inputs ($\overline{10E}$, $2\overline{0E}$) are LOW. When $\overline{n0E}$ is HIGH, the switch terminals are in the high impedance OFF-state, independent of S0 and S1.

The CBT3253 is characterized for operation from -40 °C to +85 °C.







This parameter is warranted but not production tested. The propagation delay is based on the RC time constant of the typical ON resistance of the switch and a load capacitance, when driven by an ideal voltage source (zero output impedance).


10.1. Waveforms and test circuit

V_{OI} and V_{OH} are typical voltage output levels that occur with the output load.




Fig. 6. Test circuit for measuring switching times





Fig. 8. Package outline SOT338-1 (SSOP16)
