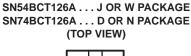

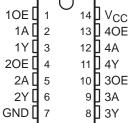

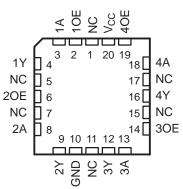

SN54BCT126A . . . FK PACKAGE (TOP VIEW)






