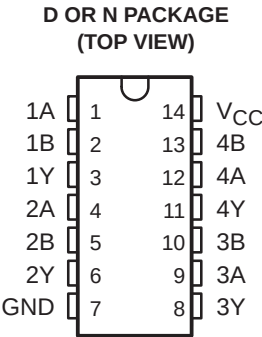

description

The SN74F08 contains four independent 2-input AND gates. It performs the Boolean functions $Y = A \bullet B$ or $Y = \overline{A} + \overline{B}$ in positive logic.

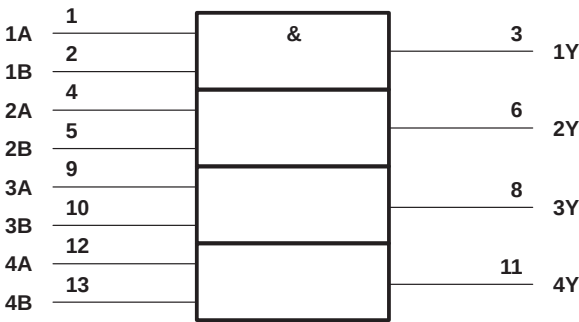
The SN74F08 is characterized for operation from 0°C to 70°C.

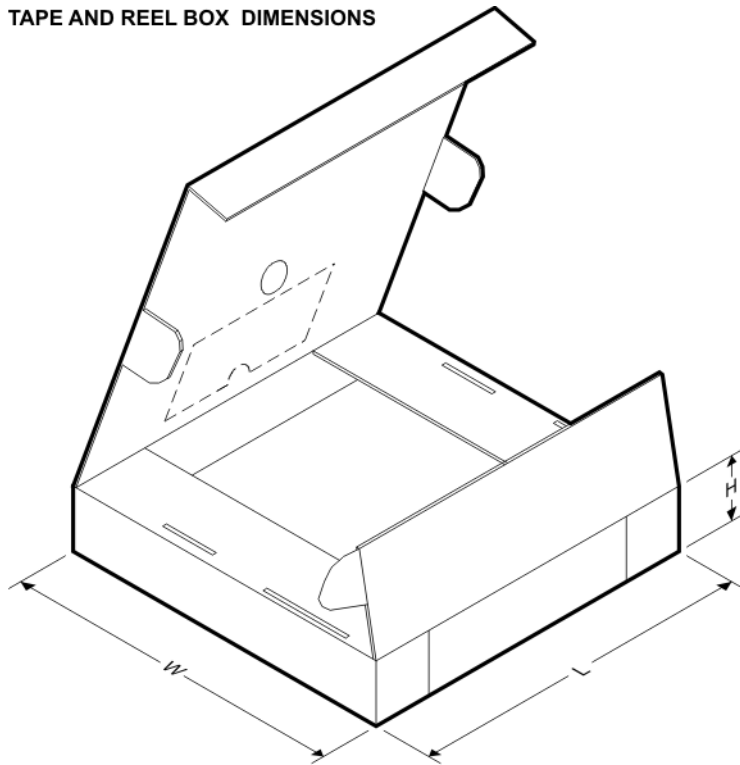
