The TC74VHC08 is an advanced high speed CMOS 2-INPUT AND GATE fabricated with silicon gate C^2MOS technology.


It achieves the high speed operation similar to equivalent Bipolar Schottky TTL while maintaining the CMOS low power dissipation.

The internal circuit is composed of 4 stages including buffer output, which provide high noise immunity and stable output.

An input protection circuit ensures that 0 to 5.5 V can be applied to the input pins without regard to the supply voltage. This device can be used to interface 5 V to 3 V systems and two supply systems such as battery back up. This circuit prevents device destruction due to mismatched supply and input voltages.

- High speed: t_{pd} = 4.3 ns (typ.) at V_{CC} = 5 V
- Low power dissipation: $I_{\rm CC}$ = 2 μA (max) at Ta = 25°C
- High noise immunity: $V_{\text{NIH}} = V_{\text{NIL}} = 28\% V_{\text{CC}}$ (min)
- Power down protection is provided on all inputs.
- Balanced propagation delays: $t_{pLH} \simeq t_{pHL}$
- Wide operating voltage range: $V_{CC (opr)} = 2 V \text{ to } 5.5 V$
- Low noise: $V_{OLP} = 0.8 V (max)$
- Pin and function compatible with 74ALS08







Input Equivalent Circuit





Unit: mm




