

Specter II USB Remote Unit for Phantom KVM Installation

Description

The Specter II USB remote unit connects to the HD15 and USB ports on a computer/server, and converts them to a single RJ45 connector. Ordinary Cat5e patch cables can then be used to connect the computer/server to the system ports on a Specter II USB (0SU51011) or PS/2 (0SU51012) remote unit. Use of Cat5e cables frees up space in the installation that would be filled by traditional, thicker KVM cables. Compliant with the Federal Trade Agreements Act (TAA) for GSA Schedule purchases.
